Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), and on recommendations of the Nomination and Remuneration Committee, the Board of Directors of the Company at its meeting held on Thursday, June 23, 2022, considered and approved the following:

i) Re-appointment of Dr. Amar Agarwal (DIN:00435684) as Chairman cum Managing Director of the Company along with remuneration for a period of 3 years with effect from October 01, 2022 and shall hold office till September 30, 2025.
