My Happy Place Private Limited (MHPPL) is a private limited company incorporated on October 11, 2025, under the provisions of the Companies Act, 2013, in which the majority stake is held by Dr. Ashar Agarwal (PAN: [REDACTED]), Promoter of the Company and Ms. Kaamna Kakkar (PAN: [REDACTED]), Promoter Group of the Company and accordingly MHPPL has been classified as part of the Promoter Group of the Company in accordance with the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018. 2. With respect to the disclosure of Significant Beneficial Owners (SBO) in Table V of the Shareholding Pattern (SHP), we would like to clarify the following: - As per our previous SHPs filed till the quarter ended September 30, 2025, with the stock exchanges: a) Dr. Adil Agarwal (PAN: [REDACTED], b) Dr. Anosh Agarwal (PAN: [REDACTED], c) Dr. Ashvin Agarwal (PAN: [REDACTED]) and d) Dr. Ashar Agarwal (PAN: [REDACTED]) were disclosed as the SBOs being the partners of Dr. Agarwal's Eye Institute (AEI) (PAN: [REDACTED]).
